No voting privileges. Not eligible for Executive positions. Able to access all CNLA member benefits.

Affiliated _____ (\$133.90 plus HST)

Affiliate members are entities that share common issues, concerns and objectives with the industry. Examples include educational institutions, municipalities, horticultural organizations and interest groups.

No voting privileges. Not eligible for Executive positions. CNLA membership is not available.

Individual _____ (\$53.55 plus HST)

No voting privileges. Not eligible for Executive positions. CNLA membership is not available.

LNL CODE OF ETHICS

- 1) Members shall observe the by-laws of the Association and give of themselves liberally for the advancement of its objectives
